## **About the Tom Grove and Betty Sheeks Law Human Service Internship**

The Tom Grove and Betty Sheeks Law Human Service Internship was established in 2000 by Betty Sheeks Law, a 1942 economics graduate, and her husband Ed. It is named for Betty and her late husband, Tom Grove. Mr. Grove was a 1942 mechanical engineering graduate. In 1972, Mrs. Law added a master's degree in social work from the University of Minnesota. She established the program to reward and encourage "someone with a passion for social action" and "someone who can be an agent of change."

## **Eligibility**

Female SDSU graduate and undergraduate students who will perform an internship for academic credit are eligible. (Internships involving school counseling or probation work will not be considered.)

## **Internship Placements and Assignments**

Candidates select their own internship site, but may seek recommendations from their advisor or other University faculty. Internship assignments are to be determined by the internship supervisor in consultation with the student and the student's internship coordinator or academic advisor.

## **Internship Duration**

Internships must be a minimum of 10 weeks in duration.

## **Financial Support**

Internship stipends range from \$1,000 to \$2,000 and are to be used for academic and living expenses associated with the internship.

## **How to Apply**

The Tom Grove and Betty Sheeks Law Human Service Internship seeks applications from highly motivated female SDSU graduate and undergraduate college students interested in furthering their education and experience in the human service and non-profit fields. To apply, submit the attached application and obtain two references, preferably one from your academic advisor, internship coordinator, or a professor and one from someone who can speak to your motivation and direction in the human service field, such as an employer or volunteer supervisor.

## **Application Deadline**

The deadline for receiving applications is March 30, 2009.

## **Selection Process**

All applicants will be notified of their application status within three weeks following the application deadline. The Grove-Law Internship Steering Committee will review submitted applications and select finalists to interview. Finalists will be interviewed before the steering committee. Stipend recipients will be informed of their status within a week following the interview.
